General Information

- 1. Each vendor will be allowed 2 entries in the show; ID badges will be issued at check in.
- 2. Doors will open at 6:00 a.m. for vendors to setup and at 8:00 a.m. open to the public.
- 3. Doors will close to the public at 3:00 p.m. and vendors will have until 4:00 p.m. to take down tables.
- 4. All vendors agree to stay from 8:00 a.m. to 3:00 p.m.
- 5. Lunch will be available from the Club's kitchen for purchase.

Vendor Guidelines

- 1. All weapons will have trigger locks or cable ties attached or in a locked show case.
- 2. No loose ammunition on tables permitted per JCOC gun show insurance policy.
- 3. Vendors are responsible for disposing of all their trash at the end of the show.
- 4. <u>No loaded firearms allowed</u> in show except for security or police officers (this includes CPL holders) per our gun show insurance policy.
- 5. Licensed vendors must display current FFL and sales tax licenses.
