**Non-Member Table Rates:** 6' table @ \$30/ea. OR 8' table @ \$40/ea.

**JCOC Member Table Rates:** 6' table @ \$15/ea. OR 8' table @ \$20/ea.

### General Information

1. Each vendor will be allowed 2 entries in the show; ID badges will be issued at check in.
2. Doors will open at 6:00 a.m. for vendors to setup and at 8:00 a.m. open to the public.
3. Doors will close to the public at 3:00 p.m. and vendors will have until 4:00 p.m. to take down tables.
4. All vendors agree to stay from 8:00 a.m. to 3:00 p.m.
5. Lunch will be available from the Club's kitchen for purchase.

### Vendor Guidelines

1. All weapons will have trigger locks or cable ties attached or in a locked show case.
2. No loose ammunition on tables permitted per JCOC gun show insurance policy.
3. Vendors are responsible for disposing of all their trash at the end of the show.
4. No loaded firearms allowed in show except for security or police officers (this includes CPL holders) per our gun show insurance policy.
5. Licensed vendors must display current FFL and sales tax licenses.
6. Vendors must have your own liability insurance on (home owner policy).
7. All cancellations must be made one (1) week prior to the event (3/21/20).
8. No refunds after March 22, 2020.
