**Consent Decree**

Good afternoon, Insiders.

A group of angling and conservation organizations MUCC belongs to that has been fighting for recreational anglers' rights received its day in court last week.

The Coalition to Protect Michigan Resources has entered a legal battle against the parties, including the Michigan DNR and the State of Michigan, challenging the biological sustainability and questionable outcomes accompanying the proposed successor decree.

Popular recreational fishing waters like Grand Traverse Bay, Big Bay de Noc, Hammond Bay and waters off the ports of Ludington, Frankfort and Grand Haven will see gill nets for the first time in more than four decades if the proposed decree is accepted.

Gill nets are incredibly efficient and effective. They can be fished with small boats and with minimal start-up costs. One CPMR concern is that local fishery stocks will be depleted to near zero, as history has shown us, and recreational anglers will be left with no fish to catch.

This is juxtaposed next to a lake trout fishery that still has not recovered. Spending two days in court listening to Tribal and State attorneys argue about how many fish they should be able to take while ignoring the elephant in the room was eye-opening.

We are currently awaiting the Judge's order, but the parties are expected to be back in court next month. The coalition and the fisheries need your help. Learn more about how to help by going here. https://protectmiresources.com/

# Commercial Guiding Bills: What's Myth and What's Fact?

The Senate Natural Resources and Agriculture Committee passed out an MUCC-supported commercial guiding package (SBs 103,104 and 105) today.

Commercial guiding in Michigan is woefully unregulated. Nothing in state law prevents a serial poacher or felon from guiding. For more than 10 years, Michigan United Conservation Clubs has worked to provide much-needed sideboards for an industry profiting off Michiganders' natural resources.

Recently, myths and mistruths have made the rounds in the media. The conservation, guiding, and natural resources communities have united behind this legislation and are working to help folks better understand what the package would and would not do.

#### Myth: This legislation represents the most restrictive guiding regulations in the nation

This is a laughable assertion.

Guides in Western states sometimes pay thousands to be licensed. In some states, those same guides have to be licensed under an outfitter that also pays thousands of dollars to be licensed.

There are states that require competency tests, too. This legislation would bring Michigan in line with most of its Great lakes neighbors in terms of the fees and requirements of commercial guides.

#### Myth: The list of requirements is too burdensome and costly

To acquire a guide license, one must:

- Have a valid hunting/fishing license
- Have a driver's license, state identification card, or a sportscard.
- Be CPR/First Aid certified
- Carry a First Aid kit.
- Be free of violations of specific game laws in the last three years and have no felonies.
- Pay a \$150 fee for a three-year guide license. The fee is waived for existing charter captains regulated by the Coast Guard.

In sum, \$50 a year, being First Aid and CPR certified and not being a convicted poacher or felon are not high bars to ask of a guide.

**Commercial Guiding Continued** 

Myth: If I am a guide and fail to report on time I now have a criminal record

Fact: Guiding without a license or failing to report are civil infractions under this legislation. Civil infractions are not a part of your "criminal record."

Myth: How can my favorite conservation non-profit run learn-to-hunt programs without becoming a guide?

Fact: MUCC and other non-profit organizations are exempted from the guiding requirement if they host events to recruit, retain or reactivate a hunter/angler.

# On the Ground: Volunteers remove thousands of feet of old bared wire from Potterville State Game Area

On Saturday, May 20, 11 volunteers joined MUCC's On the Ground (OTG) program in partnership with Eaton Conservation District and the Michigan Department of Natural Resources to remove old, degraded barbed wire fencing at Potterville State Game Area in Eaton County.

This small but mighty crew removed approximately 10,000 feet of barbed wire from the property, impacting more than 25 acres of wildlife habitat on public land. The stretch of fencing that was removed included a quarter mile of barbed wire along the Thornapple River.

During this project, our team saw a variety of wildlife enjoying the game area that was established in 2019. Species included sandhill cranes, garter snakes, a white-tailed deer fawn, and songbirds like bobolinks and meadowlarks.

Furthermore, a few volunteers assisted DNR Biologist Randy Heinze in constructing a fence along a property boundary to fulfill an agreement that was made during the acquisition of this new game area. This will help ensure that recreationists on this piece of public land won't trespass on private property.

## May NRC Recap

The deer hunting regulatory cycle began in earnest at the May Natural Resource Commission (NRC) meeting.

Chad Stewart, Michigan DNR deer and elk specialist laid out a number of proposed regulation changes which can be found in his presentation <a href="https://www.michigan.gov/dnr/-/media/Project/Websites/dnr/">https://www.michigan.gov/dnr/-/media/Project/Websites/dnr/</a> Documents/Boards/NRC/2023/May-2023/Signed\_07WCO2023\_INFO.pdf

MUCC also detailed the proposed changes in our May meeting preview.

Commissioner John Walters also proposed regulation changes, while the final language may change, the proposals he put forth are listed here:

- For ALL "Specialty Hunts" (Liberty, Independence, etc.) only antlerless deer shall be harvested.
- Single Deer License Hunter may harvest either an antlered or an antlerless deer.
- Combo License Hunter may harvest one antlered deer and one antlerless deer, or two Antlerless deer; but
  not two antlered deer. Once a combo license has been filled and recorded with the DNR, the hunter may purchase a single license to harvest either an antlered deer or an antlerless deer.
- Lift baiting ban on Upper Peninsula. If CWD is detected in a whitetail deer, the baiting ban will go into effect by following the DNR – CWD Protocol.
  - ALL Opening Days will begin on a Saturday:
- Specialty Hunts Begin the last Saturday in September.
- Bow Season Begins on the first Saturday in October and ends on the Friday before firearm deer season
- Firearm deer season begins on the third Saturday in November and ends on the first Sunday in December
- Muzzleloader Season (LP) Begins on the second Saturday in December for 10 days
- Muzzleloader Season (UP) Begins the Monday after firearm deer season for 7 days.
   Add Antler Point Restrictions (4 points on one side or greater).
- (LP) all DMU's areas where no diseases have been detected.
- (LP) all DMU's where CWD and bTb have been detected
- (UP) DMU 055, 255, 155, 022 and 121
- (UP) All Upper Peninsula

Commissioners tabled\_Wildlife Conservation Order #5 of 2023 until the June meeting, still hammering out language changes with the DNR and commissioners and until NRC Chair Tom Baird returns.

Commissioner Walters offered an amendment to the dog tracking order to remove the testing and CPL requirements, specify the tracker must be 18 years of age, removal of the GPS requirement, and that barking dogs are prohibited on public lands during legal big game hunting hours. Commissioner Anthony offered a friendly amendment to strike the barking amendment, which was accepted by Commissioner Walters.

DNR Director Shannon Lott indicated that she will be signing Wildlife Conservation Order #6 of 2023, which sets new regulations for individuals to trap nuisance wildlife at their homes.

The Commissioner's report became tearful as Commissioner Leslie Love announced her resignation from the NRC and announced her candidacy for United States Senate.

Preceding the committee of the whole, fisheries committee saw a presentation by Dr. Seth Herbst, DNR Fisheries Division on .<u>Inland Walleye Management</u> https://content.govdelivery.com/accounts/MIDNR/bulletins/3066064

Following the fisheries committee, the wildlife committee will see three presentations.

#### **Marinated Salmon Filets**

Ingredients: Boneless, skinless salmon Filets / Italian salad dressing / Prepared horse radish / Tomato slices. THAT'S IT.


Marinate the filets at least 1 hour in Italian drg. Place filets on well greased griddle over med. Flame. Top each filet with horse radish. (as much as you like).

Place tomato slice on each filet. Close grill and cook for 15 min. or until fish flakes with fork. Thicker filet may take longer.
